The purpose of this amendment is to provide answers to supplier's questions relating to this solicitation.

QUESTIONS AND ANSWERS

Question 17

Is the service provider required to purchase and provide garage doors for this property?

Answer 17

No, the garage doors are provided.

Question 18

How would this be charged back to PWGSC -Is it expected that the doors be amortized over the term of the contract or would PWGSC pay for this cost outright?

Answer 18

Not required, as doors will be provided.

Question 19

Who would be responsible for the repairs and maintenance of the garage doors after installation?

Answer 19

Not required, the garage doors are not part of the contractor's equipment required.

Question 20

On page 32 of 38 -Voice Guides, it makes reference to - payment, fee, and receipts and " not accept coins". Can you clarify if the pay station will accept bills only and if so, will the machine be expected to return change (coins) ?

Answer 20

The exit pay station should accept credit card and coins only. Dollar bills shall only be accepted by the cashier during hours of operations.

Question 21

Note that pursuant to Section 2035 29 and 30 of the general conditions, should a Contractor terminated for breach, Canada is not required to reimburse the Contractor for all unamortized capital costs but it is unclear whether or not such costs are reimbursable upon Canada terminating for convenience. Please clarify.

Answer 21

Under General Conditions 2035, section 30.2 'The Contractor will be entitled to be paid, for costs that have been reasonably and properly incurred...' and 30.2 c) 'all costs incidental...except employee severance payments and damages...' but 30.4 'The Contractor will have no claim for damages, compensation, loss of profit, allowance arising out of any termination notice given by Canada under this section except to the extent that this section expressly provides. The Contractor agrees to repay immediately to Canada the portion of any advance payment that is unliquidated at the date of the termination.'

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.
