## This amendment is raised for the ISSP Request For Proposal (RFP) number W8476-112965/B.

The intent of this amendment is to provide a clarifying response to Industry poised questions and where applicable, amend the RFP in response to Industry questions.

## Questions and Answers No. 51 to 61

**Q51.** In order to address some of the concerns raised by the Industry during the ISSP Bidder's Conference held on 1<sup>st</sup> May 2013, a new version of the Financial Bid Presentation Sheet (FBPS) for the resulting Acquisition contract is now available from PWGSC.

**A51.** Some of the changes made in the FBPS are closely related to the number of batteries and battery chargers required by DND and some quantities were updated as a result. Changes to the Contract Deliverables List for the Acquisition of the Integrated Soldier System (ISS) – Annex CF to Volume 2 are presented below.

### **Q52.** Re: TPS-4212

Evaluation criteria requires a "...comparative assessment based on similar components.."

Volume 2 verification criteria requires "Test to be done using at least five (5) ISS-S nodes. Test must be repeated to gather appropriate statistics. Test to be performed under unobstructed open terrain."

Question: Is it acceptable to provide a test report in our proposal, consistent with the Volume 2 verification criteria, in lieu of the 'comparative assessment'? If so would collecting data from 5 units over 24 hours at a known location be adequate?

**A52.** The Instructions to Bidder and the Evaluation Criteria and Scale for a certain number of GPS receiver performance related requirements have been modified in order to provide added clarity. The following requirements are affected TPS-4212, TPS-4213, TPS-4217 and TPS-4226. Note that no electronic amendment Matrix of Compliance Module (MCM) files will be issued as a result of these modifications. Bidders are requested to manually make the required changes in their respective electronic and paper MCM submissions.

**Q53.** With reference to the mandatory requirement number 5 in Table 3 following Para 4.1.3.4 in Volume 1, which states:

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contracts.

Table 3 references SACC 2003 05.1. We cannot find this requirement in SACC 2003, but we did locate a similar requirement in Volume 1, Para 4.3.1.1. Please confirm Table 3, Requirement 5 should reference Volume 1, Para 4.3.1.1, and not the SACC.

**A53.** Requirement number 5 of Table 3 in Volume 1, section 4.1.3 – Mandatory Requirements (General and Financial), should have referenced paragraph 4.3.1.1 of the same volume and NOT the SACC. A number of modifications are therefore made to Table 3 to correct discrepancies:

## **Q54.** With reference to:

- Volume 1, Annex CC, Appendix 1, Table 1, Evaluation Criteria and Scale Column, TPS-613 and TPS-4879, and
- Volume 2, Annex CB, Appendix 1, Validation Criteria Column, TPS-5127

We note that DND deleted all requirements related to "Graphical Plans" in an early draft of Technical Performance Specification (TPS) requirements prior to the first formal RFP being issued. With references to Graphical Plans now deleted, please provide amplifying details concerning what information bidders are to provide in response to Graphical Plans requirements in the above referenced evaluation criteria and validation criteria.

**A44** In the TPS, there are some references to Graphical Plans that should not be present. References to the term "Graphical Plans" have been removed from the RFP and the evaluation scores adjusted accordingly. Note that no electronic amendment Matrix of Compliance Module (MCM) file will be issued as a result of these modifications. Bidders are requested to manually make the required changes in their respective electronic and paper MCM submissions.

- **Q55.** Please confirm that a minimum of two compliant bids are not required in order for Canada to award the ISS-A and ISS-OWSS contracts.
- **A55.** A minimum of one fully compliant bid meeting all mandatory elements of the Acquisition and OWSS requirements is required to award the ISS-A and ISS-OWSS Contracts.
- **Q56.** Reference the optional ISS-S batches at section 1.0, appendix 2, annex AB to volume 2: the concept of "fraction of a batch" is very difficult for bidders to provide accurate costing on that would be beneficial to Canada as the variables between qty 1 and 628 systems is significant. Can Canada determine a minimum quantity of what a fraction of a batch means to guide Industry?

This minimum quantity would become the minimum order requirement for Canada to observe if a full batch is not purchased.

**A56.** Please reference Amendments 009 and 012 and the modifications to the ISS-A Financial Bids Preparation Sheet (FBPS).

**Q57.** The straight average used to evaluate the R&O blended labour rate requested at section 4.0 of the OWSS BoP (under In-Plant Repair) does not represent the reality of most LRU R&O cycle. Certain LRU would not have to go through R&O very often but would be somewhat expensive as opposed to some other LRUs that are less expensive and would go more often. Bidders are suggesting that an apportionment of the 53,500 hrs against each LRU entry in section 4.0 be made based on the basic reliability profile.

**A57** Please refer to Amendments 009 and 012 and the modifications to the ISS-OWSS Financial Bids Preparation Sheet (FBPS).

**Q58.** Are bidders expected to require an audiologist to determine if canal phone sets fit properly and will the audiologist/FSR deploy with the troops to theatres of operations?

**A58.** Please refer to Amendments 009 and 012 and the modifications to the ISS-OWSS Financial Bids Preparation Sheet (FBPS). The ISS-OWSS (section 12.1, part 1, annex AB to volume 3) specifically deals with this requirement for services in Canada.

Q59. Volume 1, Para 3.2.6, Table 2, & Volume 1, Ann AA, Para 8

The first reference indicates the bidder must present 2 printed copies (1 master and 1 copy) of Section 1, whereas the second reference indicates Executive Briefing Package should be on a separate CDROM/DVD.

<u>Question:</u> Must the bidder also submit 2 printed copies of the Executive Briefing Package, or does the bidder submit the Executive Briefing Package in electronic form only?

**A59**: The bidder must submit the Executive Briefing Package in ELECTRONIC FORMAT only

**Q60.** Volume 1, Para 6.3.1

Question: Please confirm which version of SACC A9033T bidders should use.
