Q4 At page 37, to what does "Contract Name" refer? How is this different from Project Title? Should contract name actually be Contract Source, which is not listed in the set of requested information?

A4 The 'Contract Name' could be the same as the "Project Title" or it could make reference to the "Contract Source" if relevant.

Q5 At page 40, when stating "No monitoring is required to ensure project is managed effectively", are you referring to the fact that there will be no monitoring required on the part of Health Canada or PWGSC? Can you further explain how monitoring is defined in this sentence?

A5 The monitoring refers to Health Canada Technical Authority having (or not) to oversee the project to ensure its success. For example, the Technical Authority should not have to remind the Contractor about deadlines, ethical issues, or raise attention to potential problems unforeseen by the Contractor.

Q6 At page 13, the link provided to verify that any of the Bidder's members are not named on the FCP Limited Eligibility to Bid list states: "As a result of the implementation of the redesigned Federal Contractors Program (FCP) the names of all the organizations have been removed from this list." Can further instruction be provided on how we are to verify that bidding members are not listed on the FCP Limited Eligibility to Bid list to ensure we are meeting this expectation in our proposal?

Q7 At page 19 & 20, in the past, the REB has requested the submission of Appendix I - Previously approved by an external Research Ethics Board the CSTADS ethics application upon approval by the ORE application form, following approval from the Office of Research Ethics. Given the time required to submit and have applications reviewed by the ORE, is it an option to move this item to Milestone 2 instead of Milestone 1 in the Schedule of Milestones?

A7 Approval from HC REB has been moved from Milestones 1 to Milestones 2. The approval must be received before pilot testing is conducted. The Schedule of Milestones, the Financial Spreadsheet and the Statement of Work have all been amended.

Q8 At page 27, this portion of the RFP requests that the Bidder should provide a short introduction demonstrating their level of understand of the project and how they view:

- -the relevance of their approach;
- -the pertinence of the examples provided in support of the application in relation to the project;
- -development challenges;
- -technical gaps; &
- -technology trends.

Would you be able to provide further description and provide definitions for the terms used within each of the 5 bullet points?
