This solicitation amendment is to provide for clarifications regarding the Request for Proposal (RFP):

Amd. No. - N° de la modif.

Q1: The RFP indicates that NRCAN will be using the helicopter on site. Will they be paying the helicopter company for its use or will the successful company pay for this?

A1: The RFP states that the supplier must "Anticipate making available the helicopter being used to support the work." This means that it is the suppliers' full responsibility to make the helicopter both physically and financially available to NRCan for the purpose of monitoring the project, thus the supplier will incur the cost of the helicopter.

Q2: The monuments and markers required for this contact are not usually stocked by survey companies. Will NRCan consider obtaining these materials as has been done on past projects?

A2: NRCan is having produced 75 CLS standard post (brass) and 75 identification plaques, as shown on attachment III, for use on this project. The Contractor will be required to contact the production company located in Chilliwack, B.C. for pick-up of the CLS standard post (brass) and identification plaques. NRCan will incur the cost for the production of these materials, however the Contractor will be responsible for the cost of delivery from the production company in Chilliwack to the work site. Any unused materials (CLS standard post [brass] and identification plaques) must be returned, at the Contractors expense, to the Surveyor General Branch in either Whitehorse or Yellowknife upon completion of the field work. It should be noted that NRCan will not be providing the Rebar Survey Post or the Marker Post and it is the Contractors responsibility to provide such material to complete the work.
