INDUSTRY ENGAGEMENT EVENT CLOUD COMPUTING SOLUTIONS

SUMMARY OF THE EVENT

The Federal Government in collaboration with Provinces/Territories and municipalities has launched a formal consultation process with Industry on the adoption of cloud computing solutions in a Canadian government context. The first consultation activity was the Industry Cloud Engagement Event held on November 13, 2014 in Ottawa. The event included an overview of the Federal Government's consultation objectives, consultation process and consultation framework. Information was provided in more detail on the Federal Government's consultation pillars, and some sample RFI questions were presented.

Following the presentations, the floor was opened up to the participants for questions and answers. The event was attended by over 85 vendors, approximately 121 people attended in person and 50 via teleconference. In addition, it had in attendance Federal and Provincial/Territorial IT leaders.

The next step in the consultation process will be the posting of the cloud computing solutions Request for Information document on BuyandSell.gc.ca. This document will be posted in the next few weeks. Industry is encouraged to review and response to the planned RFI.
