As result of the Early Engagement process, Canada has gathered valuable feedback from Industry Participants.

Early Engagement Activities Completed:

- A Draft Statement of Work was posted on Buyandsell.gc.ca
- Industry Day and one-on-one sessions were held
- A Draft Request for Proposal (RFP) was posted on Buyandsell.gc.ca
- A Site visit conducted.

Summary of feedback received in response to this LOI process (Draft RFP)

Topic	Feedback	Response
Subcontractors	Clarification was requested on how bidders are to include proposed subcontractors in their bid, and whether or not the subcontractor's experience will form part of the evaluation.	It is Canada's intent to consider in the bid evaluation the combined strengths, background and experiences of the combined bidder's team, including subcontractors.
Resources	Clarification was requested on the possibility of bidders offering some of the same personnel on multiple RFPs.	Bidders may submit the same personnel for multiple RFPs however, in the event of the bidder winning multiple contracts, the bidder might have to substitute personnel with individuals who possess equivalent qualification and experience. Failure to do so could result in the bid being non-compliant. See SACC Clause A3005T for more information.
Financial Evaluation	Some improvements were suggested on the method of calculating the Total Evaluated Cost.	The financial evaluation will be reviewed and adjusted as needed in the final RFP.
Transition Plan	It was suggested to request a Transition Plan as part the bid.	The creation of the transition plan is the responsibility of Canada. The transition plan will be detailed with the winning bidder.
Technical Evaluation	For the point rated part of the technical evaluation, it was suggested that we allocate the maximum number of points to experience acquired on Land C4ISR projects.	The point rated technical evaluation might change in the upcoming final RFP, but we intend to use an evaluation method that is inclusive to experience acquired in a broader defence and security context.
Technical	Some inconsistencies were pointed out in	This will be reviewed and
