AMENDMENT #001

This amendment solicitation is raised to:

1) Provide Meeting Minutes of the mandatory site visit on November 16th, 2017; and

2) Answer question(s) from the industry.

1) During bidders' visits to Regional reception Centre Institution, observations were made about various elements which raised some questions. Clarification would be useful here in order to standardize the information provided to bidders and eliminate any possible ambiguity.

Additional information:

- A. The equipment cabinet must be installed in the basement on either a concrete or metal base in order to provide a levelled surface. If a metal base is selected, the base must be anchored to the existing concrete floor. The cabinet must be attached to the base with bolts. Wood is not acceptable material for the base.
- B. The electrical circuit for the equipment cabinet must come from the ELP-5E located in the basement 15 meters away from the equipment cabinet planned location. The contractor is responsible for the wiring and the breaker installation in the electrical panel in accordance with the Canadian Electrical Code.
- C. As indicated in Statement of technical Requirements section 4.4.10, connection to the electrical must be done at zero energy. The contractor must schedule that activity with the institution.
- D. Inside the 8 visit booths, conduits coming from the cameras towards the basement must be secured with clamps using double anchoring and anti-vandal screws. Junction boxes are not permitted in the 8 visit booths.
- E. The Omnicast software version currently being used is 4.8.
- F. In the equipment cabinet, equipment installation must be start from the bottom of cabinet. The uninterruptible power supply and its battery must be installed at the lowest point. Free space can be left between the equipment to allow for heat dissipation and in accordance with manufacturer's specifications. An arrangement drawing must be submitted by the contractor to the Chief, Electronic Systems Maintenance for approval.
- G. The Network video user station (NVUS) must provide viewing of images coming from the 8 visit booths only. No other image must be accessible by this NVUS. No storage is permitted with this NVUS. The computer must be installed in the equipment cabinet. The display and mouse must be installed in the control room (room B-111). NVUS shut-down form the monitor located in the control room is not allowed.

- H. CAT6 cables coming from the cameras must be terminated on a patch-panel installed in the equipment cabinet.
- I. The contractor must demonstrate that at least one of his team members has an Omnicast certification.
- J. In the basement, rigid conduits installed by the contractor must be attached to the ceiling above vent plenums and plumbing.
- K. Image streams coming from the 8 cameras must be forwarded to the archivers located in the Common Equipment Room (CER). The contractor must modify the existing system to achieve this requirement. Video archiving is currently achieved using Pivot 3 servers.
- L. On a video loss from any of the 8 cameras, an alarm must be programmed in Omnicast in order to be displayed on the Facility Alarm Annunciation System (FAAS).
- M. With the addition of cameras in Omnicast, the contractor must add the required licenses.
