(1) Bidder's Question and Answer

QUESTION # 76:

SOW Part D Stage 2 Schematic Design and Stage 3 Design Development: There are a number of references made to "Budget / Price Proposals / Cost figures" to be supplied as part of the reports, presentations and submissions during these stages (post contract award). It is our understanding that the contract will be awarded based upon a Fixed Price Lump Sum submission.

Please confirm that it is a fixed lump sum price and if so clarify the intent for the strategy with regard to these requirements and our understanding of the contract award methodology.

ANSWER # 76:

Canada confirms that a subsequent contract will be a firm fixed price contract. To support SOW Section D 1.7 Cost Management, the Contractor must ensure the delivery of the project within the firm fixed price.

Requests by GAC for price proposals are limited to

- SOW Section D 3.4 Updated Furniture and Storage Requirements Report: proposals for two (2) different furniture systems and furnishing types to be used in the non-public spaces, and two (2) different soft seating and furnishing types and arrangements for the VIP and public areas. For the purpose of the bid submission, the Bidder should incorporate the lower of the respective cost options (see Amendment 002 of the RFP below).
- SOW Section D 2.5 Interior Décor Requirement Report: a cost summary and/or anticipated budget for the option presented must be included in the report.

Other references to "Budget / Cost figures" in the SOW are to support the tracking and cost management of the Work.

(2) Amendment 002 of the Request for Proposal (RFP)

The RFP is hereby amended as follows:

- Delete subparagraph 1(a) of Section 4.2(c) R5 Understanding the Project:

Storyboard with narrative of the Public Presentation and the intended messages and impact on visitors;

- Insert the following as new subparagraph 1(a) of Section 4.2(c) R5 Understanding the Project:

Storyboard with narrative of the Public Presentation and the intended messages and impact on visitors using interactive, virtual reality and augmented reality technology to make maximum impact and further reinforce our innovation messages;

- Insert the following Note to Annex A – Pricing Table:

For the purpose of calculating Item 10- Furniture, Fixtures and Equipment, the Bidder should incorporate the lower of the respective cost options for the furniture in the non-public spaces as well as the VIP and public areas as required under SOW Section D 3.4 Updated Furniture and Storage Requirements Report.
