QUESTION # 123:

What information does the Bidder need to provide if the Bidder is a Joint Venture/consortium?

ANSWER # 123:

If the Bidder is bidding as a Joint Venture the bid must indicate this clearly. In order to be considered a "Bidder", all members of the Joint Venture must submit the necessary information with the bid including, but not limited to, the full legal name of each member of the Joint Venture as required in Form 1- Bid Submission Form and the PBN number for each member of the Joint Venture under "Bidder's Procurement Business Number" in Form 1- Bid Submission Form (note if the PBN number is not provided at bid submission time it is acceptable to provide it before contract award). The bid must be signed by all members of the Joint Venture unless one member has been appointed to act on behalf of all members of the Joint Venture. For further information please refer to section 2.7 Joint Venture of the RFP.
