This amendment to the Letter of Interest (LOI) is to provide the following questions and answers regarding the previous posting requesting industry feedback:

Q1: Is there any historical data available that could provide an estimate on client volume/ referrals to the service in a year?

A1: The intake (new eligible clients) for the past three fiscal years are:

2016-17	4717
2017-18	4105
2018-19	3953

Q2: Can you provide an idea of what the budget for the contract might be or the estimated value of services?

A2: No, we will not be releasing the estimated budget or the estimated value of the services. However, we will continue to provide the historical information and estimated forecast of the clients.

Q3: Are you able to send a further breakdown of the VAC Rehabilitation Program Clients by the 3 categories (Medical, Psycho-Social, and Vocational Rehabilitation) introduced in the initial LOI release?

A3: We are not able to provide a breakdown of the 3 categories. However we can provide the breakdown of Vocational Rehabilitation as of March 31, 2019, there were 1,989 active clients with the current vocational rehabilitation contract.

Q4: Can a website link be added in the response or will the information provided in the link be counted towards the 25 page responses limitation?

A4: We would prefer all information be provided in one proposal document. Any information provided in the document will count towards the page limitation.
