- .2 The contractor will inform the Parks Canada heritage representative on-site who will provide direction, with functional input from the Curator CCCB, prior to any intervention that might negatively impact the artifacts in any way. This would include impacts such as dust, vibrations, physical contact with or displacement of objects. 2. QUESTIONS AND ANSWERS

Q1. Is it the intention to use Cavityrock inside the exterior studs per 07 21 00 – 2.1.1.1? This product is manufactured for rainscreen assemblies. The Rockwool insulation for stud voids would be the Comfortbatt.

A1. Rockwool Combortbatt should be used in the stud cavities. Specification section 07 21 00 revised, refer to paragraph 1.1 in Addendum 01.

Q2. For the moisture and mould resistant gyproc of the CB2 and CB4 wall tags I was wondering if the paper-face moisture resistant or the glass mat faced moisture resistant was desired. Both types are specified separately at 09 21 16 – 2.1.2 and 2.1.3.

A2. Either paper-face moisture resistant or glass mat faced moisture resistant is acceptable.

Q3. Is there additional information on the locations of the penetrations needing the sprayfoam? This work is described at $07\ 21\ 00 - 1.1.1.2$.

A3. This section is deleted, refer to paragraph 1.1 in Addendum 01.

Q4. Regarding to the application of IKO AquaBarrier AVB, IKO AcrylicStick SA, and IKO AquaBarrier VP as alternate to the referencing product.

A4. The submitted product does not meet the thickness as per specification, and therefore not acceptable.

Q5. Section 09 91 13 exterior finishes is referenced in section 06 20 00 Finish carpentry but not included in the specifications.

A5. Delete 09 91 13 reference in section 06 20 00 FINISH CARPENTRY, refer to paragraph 1.2 in Addendum 01.

Q6. No appendix for schedule of colours and finishes is included.

A6. Delete paragraph 2.1.1 in 09 30 13 CERAMIC TILING, refer to paragraph 1.3 in Addendum 01.

Q7. Heritage notes on page A0.0. Number 2, Construction to meet the requirements of heritage expectations. What are these expectations?

A7. Drawing A0.0, HERITAGE NOTES 2 revised to: CONSTRUCTION TO MEET REQUIREMENT IN SPECIFICATIONS 01 14 00 WORK RESTRICTIONS, PARAGRAPH 1.8.

Q8. Section 01 14 00 1.8 Heritage Building Requirement is general in nature. Many existing components are specified to be refinished or otherwise worked on or near. Please define protective measures referred to in section 01 14 00 1.8.4?

A8. Refer to specification section 01 56 00 TEMPORARY BARRIERS AND ENCLOSURES, paragraph 1.12.

Please define scope and level of protection required.

A12. Specification section 01 14 00 WORK RESTRICTIONS, paragraph 1.9.1 revised, refer to paragraph 1.4 in Addendum 01.

Q13. Section 02 41 99, 3.3.1 Salvaged Material

Please define 'salvage', is it more than remove cladding and transporting to specified location?

A13. Refer to specifications section 02 41 99 DEMOLITION FOR MINOR WORKS, paragraph 3.3.

Q14. Many of our sub trades will be shut down for holidays for the coming weeks, please extend closing by a week to allow for sub trade coverage.
