This amendment to the solicitation has been raised to extend the closing date and provide response (R) to questions (Q) received as below:

Questions and Responses (numbering continues from previous amendment):

Q27: Annex D – Insurance Requirements

The annex provides some commercial general liability insurance requirements, while the tender on hand relates to the provision of an UAV services. Are there any other insurance requirements we should relate to?

R27: Canada wishes to clarify that the RFP is not for the provision of RPAS (UAV) services, it is for the provision of an RPAS (UAV) as defined in the Statement of Work. The work of the contractor does include flight testing in Iqaluit.

Please refer to Resulting Contract Clause 7.12, Insurance - Specific Requirements, for the Contractor's obligations in regards to the insurance requirements specified in Annex D and any additional insurance coverage. It is the Contractor's responsibility to determine the type and amount of insurance coverage the contractor needs to fulfill its obligations under the Contract. Annex D specifies some minimum requirements.

Q28: Clause 6.4 Insurance – Proof of Availability Prior to Contract Award

Our company is covered with insurance policies by insurance companies licensed to operate in our country (referred to country is a foreign country, not a Canadian country). Said policies are valid in Canada.

- a. Shall the proof of availability be presented while applying to the tender, or only once an award notice is given to the winning bidder?
- b. Are policies provided by foreign insurance companies eligible for the tender

R28: a. The answer to this question is stated in Clause 6.4. "If the information is not provided in the bid, the Contracting Authority will so inform the Bidder and provide the Bidder with a time frame within which to meet the requirement. Failure to comply with the request of the Contracting Authority and meet the requirement within that time period will render the bid non-responsive."

- b. The answer to this question is stated in Clause 6.4 " The Bidder must provide a letter from an insurance broker or an insurance company licensed to operate in Canada stating that the Bidder, if awarded a contract as a result of the bid solicitation, can be insured in accordance with the Insurance Requirements specified in Annex D."

Q29: The following three (3) questions were received regarding extending the RFP closing date:

- I. It's a difficult time in making the right coordination to respond to your tender. Is an extension being considered?
- II. Are there any effects on the RFP schedule due to the Corona virus situation?
- III. The worldwide COVID-19 situation is creating significant delays in producing a quality proposal in time. Therefore, at this point, and subject to further restrictions, we request an extension to the Solicitation closing date to 29 May 2020.

R29: Canada has extended the closing date by one (1) month to 2020/05/21.
