Question No.	Question	Response
002	Is there a requirement take over the leases of some or all of the current PHAC-provided accommodation?	No, there are no leases currently involved in the PHAC provided accommodations.
003	The business model options you list cover a broad spectrum. It would be helpful to know if PHAC have a preference for a centralised business model for ease of coordination or a regional arrangement that caters more closely to local situations.	PHAC is interested to learn through the RFI what options are available but is very interested in simplifying the management of the services associated with the Designated Quarantine sites. A single provider for all of the sites would help to simplify the delivery.
004	Can you please briefly outline the proposed compensation arrangements for the planning, preparation and execution phases of the operation?	At this time, we need to hear more about the proposed compensation arrangements from industry in order to formulate an approach for payment for the various execution phases of the operation
005	Does Canada have a count of how many sites there are in total? And the sizes/type of site needed i.e Mobile or stationary.	Public Health Agency Canada (PHAC) is currently managing 11 Designated Quarantine sites (DQS) in 9 cities across Canada, with capacity to lodge up to 1600 travellers. In Annex C of the RFI potential future DQS Locations Near High Volume Ports of Entry are listed.
