- 2. To ensure consistency and quality of the information provided to Bidders, PWGSC will examine the content of the enquiry and will decide whether to issue an amendment.
- 3. All enquiries and other communications related to this bid sent throughout the solicitation period must be directed ONLY to the Contracting Authority named in paragraph 1. above.—Failure to comply with this requirement may result in the bid being declared non- compliant.

#### SI03 OPTIONAL SITE VISIT

- 1. There will be a site visit on December 6, 2021. Interested bidders are to meet at the Regional Psychiatric Centre located in Saskatoon, SK. <u>Bidders are required to notify the contracting authority prior to December 2, 2021</u> if they would like to attend. A time will be scheduled individually for any contractors wishing to attend.
- 2. Safety Attire: In order to be guaranteed access to the site visit all persons must have safety masks(no cloth masks are allowed, there will be masks available at the entrance), be required to have their temperature taken at the entrance and will be required to social distance as per AHS guidelines. Contractor's personnel/individuals who do not have the proper safety attire may be denied access to the site.

- b. obtain additional funding and award the Contract to the Bidder submitting the lowest compliant bid.

#### SI09 BID VALIDITY PERIOD

- 1. Canada reserves the right to seek an extension to the bid validity period prescribed in BA04 of the Bid and Acceptance Form. Upon notification in writing from Canada, Bidders will have the option to either accept or reject the proposed extension.
- 2. If the extension referred to in paragraph 1. above is accepted, in writing, by all those who submitted bids, then Canada will continue immediately with the evaluation of the bids and its approvals processes.
- 3. If the extension referred to in paragraph 1.above is not accepted in writing by all those who submitted bids then Canada will, at its sole discretion, either
  - a. continue to evaluate the bids of those who have accepted the proposed extension and seek the necessary approvals; or
  - b. cancel the invitation to tender.

- 4. The policy may exclude or be endorsed to exclude coverage for loss or damage caused by asbestos, fungi or spores, cyber and terrorism.

The policy must have a limit that is **not less than the sum of the contract value** plus the declared value (if any) set forth in the contract documents of all material and equipment supplied by Canada at the site of the project to be incorporated into and form part of the finished Work. If the value of the Work is changed, the policy must be changed to reflect the revised contract value.

The policy must provide that the proceeds thereof are payable to Canada or as Canada may direct in accordance with GC10.2, "Insurance Proceeds" (<a href="https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual/5/R/R2900D/2">https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual/5/R/R2900D/2</a>).
